

We are proud to announce that over the past few months, the **Netherlands France Chamber of Commerce (NFCC)** has initiated, coordinated, and led the development of the very first edition of the *Annual Trade & Investment Barometer*, a cornerstone initiative of the **2025 France—Netherlands Economic Year**.

Launched in close collaboration with the **Embassy of the Kingdom of the Netherlands in France**, and with the valued support of **PwC Netherlands**, **ING**, and **SEO Amsterdam Economics**, the Barometer offers a **comprehensive, data-rich picture** of the evolving Franco-Dutch economic relationship.
